A moment of silence for the memory of Jim Smith

A motion to approve the October 11, 2022, Board Meeting Minutes was made by Councilperson Haar and seconded by Councilperson Kenyon, with all in favor.

Guest Speaker Legislator Horton;

Legislator Horton spoke on the Sheriff's Driver Diversion program. It is a program where you get a normal vehicle and traffic ticket, you can enter in and keep yourself from getting points on your license. Part of those funds are rolled into a reserve and the Sheriff's Department was able to purchase 5 new vehicles out of that program.

Also, the Sheriff's department now has a food service that will take over the first of next year. That will cut down the need for overtime because the guards are covering the kitchen staff. Mr. Horton stated that the number one question that people ask, is if taxes will go up. He stated that the total assessment of the County went up around 2.2%. The 2023 budget increase is 1.5%. So, tax payers may see a decrease because of the assessed value increase. Mr. Horton also stated that redistricting was voted down.

Guest Speaker Sheriff Allard;

Sheriff Allard spoke on the noise ordinance. He spoke about what can actually be enforced, if it is a Town law, and how the State Police and, or, the Sheriff's Department handle a Town law. We take copies of the law to the County Attorney to make sure that it's lawful and Constitutional. Then we go to the Town Attorney and get verification that they will actually prosecute it. If the Town Attorney isn't going to prosecute, law enforcement will not make an arrest. When it comes to prosecution, you have to have a decimal meter. Loud is a vague term.

The Town of Wayne has a policy to educate and hopefully encourage people who live in the town to be respectful of their behavior.

A copy of the Policy will be mailed to property owners in the Town of Wayne.

Supervisor's report;

Supervisor Mahr stated that there are budget modifications, that need to be made this month to offset line items going negative with the vouchers that are to be approved at this meeting. We are looking for areas that we are not going to spend money on between now and the end of the year, moving money from there over to areas where the need is. We did get a bill for \$5,100.00 for the swim program. We only had \$2 500.00 budgeted.

In Highway, paying the Suit Kote bill, in the November vouchers, will exceed what is left in the budget for general road repairs. We have gotten the CHIPS back up to \$100,000.00, because we deposited a check for \$38,000.00 earlier this year. We moved it into the budget last month.

The Highway budget year- to - date expense is \$463,144.00, which includes E. Lake Rd paving. The Town has a truck ordered with a possible delivery in February 2023, for \$265,000.00. The equipment reserve has \$217,000.00. What we feel comfortable doing now is do a resolution to move \$55,000.00 out of Chips and move that into that reserve.

The Vouchers were kept open beyond the usual cut-off date to pay additional bills that came in, for Nymor, the swim program, DSD webworks bills and postage. We also have 3 checks for Tops for the Volunteer gift cards, because Tops can only do 10 gift cards at a time.

Justice report; \$1371.00 in fees were received.

Highway Superintendent report; 436 gallons of fuel was used this month. Paving on E. Lake Rd is completed, other than the shoulders. We are waiting for a road widener to come in, to rent to do the shoulders. Road signs will be replaced during the winter. The Coryell Rd was oiled and stoned, and Keuka Hill Rd from Rt 87 to Rt 230. We received shared services from the Towns of Bradford, Urbana and Coleman for that. 2013 Western Star was inspected.

A road sweeper for the oil and stone. There is a sink hole that developed at Rt 54 and Hyatt Hill Rd. the state DOT was contacted, and Steve Birch came to look at it. There was a small hole that was 9 feet deep.

A load of topsoil was donated by Jack Shuemaker, for the cemetery. The Highway will be getting CHIPS re-imbursement check for \$128,215.34, by December 15th.

Zoning minutes were approved. Planning minutes are still a draft because their meeting is next Monday.

We are waiting for Code Officer Harrop's feedback. Mr. Buck also put a resolution in there for approval for a scheduled a Public Hearing, for November 22. Our Attorney will put together the law and help us file it.

The engineer that designed the septic system said shutting down that bed will fix the problem. If that is the case Supervisor Mahr wants that in writing.
