PLEDGE OF ALLEGIANCE

Motion to approve minutes;

Correction to the minutes; Subject to adding to the Highway Superintendent report, the following: The John Deere Loader quote is \$221,964.00, the quote number is 27822749. Motion to approve corrected minutes made by Councilperson Bauer, second Councilperson Harr, Councilpersons Bauer, Haar and Kenyon are in favor. Councilperson Freeman abstained, as she was not present at that meeting.

Guest Speaker; County Legislator Horton was rescheduled for the April Board meeting.

Supervisor's report;

There was a decrease in the report from the previous month, because we paid the fire department their money for the year. We also paid insurance bills and membership fees. There was also a deposit of \$22,673.00, which we received from Charter Communications, which is the fee that they pay us to have their presence in our town.

Supervisor Mahr explained that the uncleared vouchers, are the outstanding checks.

The AUD will be done by the end of the week.

Supervisor Mahr stated that Steuben County an \$8,000,000.00 award bid to Empire to run fiber into the County. The intent is to serve 2200 homes that are not getting internet. Mr. Horton will update us at the April Board Meeting. Mr. Horton will also address the occupancy tax law.

Clerk's report;

The clerk issued One death certificate, one watershed fee, one property transfer, five building permits, one permit without a permit, two subdivisions and nine dog licenses, Motion to approve the Clerk's report made by Councilperson Kenyon, second by Councilperson Haar. All are in favor

Tax report;

The tax collector is doing a great job of collecting the taxes. The books for taxes will close at the end of March.

Vouchers;

Supervisor Mahr explained the reprint of the KWIC check for \$1,800.00, due to an address change that we were not aware of.

Highway Superintendent report;

Fuel usage was 569.2 gallons, sanding roads, filling pot holes. We cut out and repaired soft spots on Hyatt Hill. We are working on updating and replacing road signs.

Superintendent Howard reserved the dumpsters for the town clean up day, which is on May 20, 2023
