APPROVAL OF MINUTES

Motion to approve the December 2022 minutes made by made by Councilperson Haar, seconded by Councilperson Freeman. All in favor.

SUPERVISOR REPORT;

The Town received and deposited the CHIPS check. The funds, as previously discussed, were transferred to the equipment reserve. There is enough money to buy the new truck with \$140,000.00 left over. We also received the County sales tax adjustment check in the amount of \$169,000.00. The line item for Cash Checking, in the General fund account shows a balance of \$558,000.00. The reason that has increased is that we received both American Rescue Fund Checks, 2022, totaling \$100,000.00, along with the County Sales Tax adjustment.

We will receive another adjustment check for \$169,000.00 in the first quarter of this year.

The Town also received a Mortgage Tax Check for \$9,500.00 more than we expected. In the budget, the negative line items were corrected with Resolution 28.

Abstract 13 is complete, however, incoming bills for 2022 will be accrued in Abstract 14.

Clerk's report

We had an increase in fees of \$953.70 from 2021 to 2022.

Building permits and dog licenses were issued. The DEC account is up to date and balanced.

In Abstract 1 for 2023, we did purchase 10 rolls of stamps at \$60.00 per roll. We also paid into the Retirement fund, from the General Fund, and Workman's Compensation, split between the General and Highway funds.

Highway Supervisor report;

The Highway department used 504.4 gallons of fuel this month. The two, one tons were inspected. We are plowing and sanding roads as necessary, checking culvert's, picking up limbs and blown over trees. The compost is closed for the season.

The truck cab and chassis is in Rochester. They will be delivering it in the next few weeks to Wilbri, where they will install the equipment on it.
